1. **AGREEMENT OVERVIEW:** This agreement contains the entire understanding between LAKESIDE STORAGE & MUSEUM and Name/Company name, henceforth known as "COMPANY".
2. **LOCATION AGREEMENT:** This location agreement will confirm that the undersigned as LAKESIDE STORAGE & MUSEUM grants permission for the COMPANY to access Lakeside Storage and Museum.
3. **TERM:** The COMPANY is allowed on property between business hours, Monday- Saturday 9am-6pm, unless otherwise specified by Lakeside Manager.
4. **ONLINE SHARING:** COMPANY agrees to allow LAKESIDE STORAGE & MUSEUM to share images online and through their blog and other social media sites. 6. **DAMAGES/REMOVAL OF PROPERTY:** COMPANY agrees and accept all responsibilities, damages, and liabilities that myself or my group my cause and will not hold LAKESIDE STORAGE & MUSEUM accountable under any circumstance. COMPANY agrees that if a damage is made, they will immediately let LAKESIDE STORAGE & MUSEUM management know, so they can assess the damage and bill an invoice (if necessary) to above address and email address. COMPANY understands and agrees that any removal or damage to property, COMPANY is held responsible. COMPANY agrees to pay for any damages left or items removed either by myself or by my group.
